PAYMENTS

These transactions are processed twice per month. Customer has payment options of the 1 st or the 16 th of each month.
DEPOSIT AND FEES
A deposit of \$50.00 will be held in a non-interest bearing account for the duration of this agreement. A thirty-day notice of intent to terminate and a minimum three month stay is required for return of said deposit. Additionally, there is a one-time, non-refundable, \$50.00 new customer processing fee. All fees and deposits are transferable within the Blocked Inn, LLC network.
NSF AND LATE FEES
Payment is due on theof each month. A \$25.00 NSF fee will be added to your account for any returned ACH items. A \$25.00 late fee will be applied if payment is not received within five days of ACH item being returned. If payments haven't been settled within fourteen days of ACH item being returned, the Customer will forfeit their deposit and this agreement will be terminated.

TERMINATION OF CUSTOMER AGREEMENT
